Andrea Guerrini reappointed as president of WAREG, the European water regulators association

Milan, 8 March 2023 – Andrea Guerrini, member of the ARERA Board, was once again confirmed as President of WAREG, the European association of water service regulators, at the 27th General Assembly of the association, held in Lisbon. The two-year appointment, renewed after those of 2020 and 2018, confirms ARERA's important role in regulating water services in Europe.

"The European water sector has made significant progress in recent years," commented Andrea Guerrini, "but there is still much work to be done to promote effective water regulation at European level and ensure that consumers can receive high-quality water services at reasonable prices. My commitment as President will be to continue building on past successes and to work with all members of the Association to promote consistency, transparency and accountability across Europe."

WAREG¹ is the association of regulators (some of them independent authorities such as ARERA, other offices or ministerial agencies) responsible for the regulation of water systems in Europe (in total 31, of which 26 Members and 5 observers) based in Milan at ARERA.¹

Founded in 2014 on the initiative of a group of authorities in the sector, including in particular the Italian one, its main objectives are cooperation between regulators in the water sector, the promotion of common principles and a harmonized and stable regulatory framework at European level within the Community institutions.
